GOVERNANCE BOARD MEETING MINUTES February 8, 2018

Call Meeting to Order:

The South Beach Regional Fire Authority Governance Board Meeting was called to order by Board Chairperson Alfred Schroeder, representing Commissioner District Five at 5:00 PM. Sam Schlegel representing Commissioner District Four and Teresa Hart, Governance Board Secretary was absent.

The Pledge of Allegiance was recited.

Agenda Modifications:

Secretary McNett noted that there were the following agenda modifications:

BOARD COMMITTEE REPORTS:

Contract Committee: Commissioner Parnell reported on the newly formed Contract Committee which

meeting and its purpose is to establish written contracts to provide RFA services to property outside the RFA or inside the RFA with exempted property. The committee has met and Bob wanted to thank Secretary Teresa Hart for her assistance on the project. This is a follow up to the actions described during the January 11, 2018 commissioners meeting.

Actions taken:

 Committee has obtained Grays Harbor Assessor's Parcel information showing Parcel Number, Ownership, land value, improvements, Status (Exempt) for 2018. Teresa Hart reviewed and printed Parcels listed as exempt for 2018 for Committee Use:

 Chief Cole obtained and provided Committee several Sample Copies of other RFA service contracts and our Attorney provided a suggested contract form. Samples included Grays Harbor Fire Protection District #5 and RFA attorney drafted form.

Questions are to confirm RFA voter levy rate approved by fire district for collection in 2018. In addition to confirm the 69 WA State Parks parcels listed are within the RFA district. It was confirmed that the rate is 2.86.

Recommendations are that the RFA use our Attorney prepared service contract form and modify use such as private or municipal. Exhibit "A" would be a listing of property parcel number, assessed value, and RFA levy rate. Suggested is an excel sheet for clients with several properties to help clients identify property.

Actions taken would be for the commissioners to make a motion to approve RFA Service Form and Excel Sheet format if used.

The follow up action is to prepare excel sheets for each of the clients listed above, and others that may be identified using voter approved levy rate for 2018 and to prepare service contract forms. A RFA representative should present the proposed service contract.

Commissioner Bearden questioned whether annexation might be a better option? Art stated that annexation would need to be discussed with our attorney and he is of the belief that it doesn't work as well. Commissioner Parnell stated he would like to make a motion to move forward with a contract being prepared by Brian Snure. Motion seconded by David McLellan. Motion carried.

Chief Cole will be contacting Brian Snure for his assistance.

PAGE 3-RFA MINUTES-FEBRUARY 8, 2018:

BOARD MEMBER REPORTS:

Commissioner District One, Bob Parnell stated that the City of Westport would like the RFA to modify the RFA contract in regards to providing fire permits, code enforcement, fire investigation and fire prevention to the community. An action agreement could be signed designating who would be doing the services. Bob stated that the City is hopeful that the RFA will continue to perform the same services they have with the City. He noted that Commissioner Bearden was concerned that it could cost more, due to the time needed to perform. The City would like it to be seamless and hope to secure an agreement soon. Bob also thanked Chief Cole for the boxes located at the office, with the keys in it. Bob was also appreciative of the services the RFA employees have been involved in; it was his understanding that they had been busy.

Commissioner District Two, Three and Four all declined any reports.

CHIEF'S REPORT:

- Chief Cole stated Paramedic Jeremy Causey is our contact person for Active 911.
- In each packet was a picture of our new department signs. It was noted that it also states the phone number to phone.
- 30 day close for our property sale. We are waiting for one to get back from fishing. Bob questioned
 whether someone else was interested in the property. Art stated yes but the first person was willing to
 pay the full amount. We have accepted the first offer.
- Oxygen tanks that are excess have been returned; this is a cost savings.
- · Background checks are nearly done.
- Cameras at stations are now installed; they are night vision.
- Upgraded the security on doors, they have dead bolts and a key pad.
- Our temporary maintenance person has been busy and has completed several tasks.
- Our medic unit is in the shop but will be repaired soon.
- Engine 311, located at Westport had its annual pump test and needs approximately \$15K worth of
 repairs. It has tank issues, valves that must be transferred to electronic. Chief Cole is asking for
 approval as we have \$84K in the line item for repairs.
- . In September, we will be writing a grant.
- PUD has an energy program that will pay 50% of updates. We are getting site plans for each station.
- New handbook for each commissioner has been supplied to them.
- Morale remains good.

Chief Cole would like to get the approval for repairs tonight as it will be out of service for at least 1 month.

Commissioner Parnell would like a written breakdown of what is going to be replaced. Commissioner Bearden made a motion to approve up to \$15K for the repair of Engine 311. Motion seconded by Commissioner McLellan. Commissioner Parnell stated he would like to see the repair list written down, rather than just asking. Chief Cole stated it isn't black and white, as they aren't totally sure and they are the only ones that can do the repair. Vote was taken and the motion carried. The company is Hughes.

*Breakdown of calls/alarms for 2018:

BC Dennis Benn presented a slide show that shows we took 1600 calls for 2018. (see attachment) Commissioner McLellan questioned whether there is a way to place a crew in the Tokeland area. We are considering the feasibility. The reserve staff has been very helpful, as we are a true combination department.


