A regional plan, with the goal of maximize efficiencies and improve service delivery to the citizens was developed. This plan was successfully passed by vote of the people and created South Beach Regional Fire Authority on October 1, 2017.

South Beach RFA delivers comprehensive emergency services including Fire Protection, Prevention, Emergency Medical Services and Patient Transport. The Regional Fire Authority serves approximately 6000 residents which increase to as much as 12000 in the summer due to tourism. The diverse service area includes industrial, commercial, residential, forest land and the Pacific Ocean beaches.

The Regional Fire Authority delivers professional service with state-of-the art fire, rescue and emergency medical apparatus and equipment with exceptional firefighters and EMS Personnel both career and volunteer. Our proud professionals respond to approximately 1750 emergency 911 service calls each year.
