### **Call Meeting to Order:**

# **NEW STATION DESIGN-REPORT/BATTALION CHIEF VANDERVEUR:**

BC VanderVeur and BC Brown noted that they had attended a worthwhile conference in Rosemount, Illinois. Three days of classes were attended with an ample amount of information obtained. The first step is to seek an architect who can prepare a study of our current site and what we could expect if we were to attempt construction. BC Brown would like to take the step to go through with contacting an architect firm that is listed within the MRSC. A motion was made by Tom Bearden to proceed with securing an architect for the purpose of preparing a blueprint of our property. Motion seconded by Sam Schlegel. Motion carried. BC Brown and VanderVeur will be contacting Brian Snure to make sure that we are following the necessary steps and protocols to be compliant with the State Audtior.

#### **CHIEF'S REPORT-Chief Dennis Benn:**

## **DISCUSSION ITEMS:**

- 1. Discuss Paramedic Situation: Chief Benn stated that we have four candidates that went through the Paramedic Testing process and the top two candidates: Brenna VanderVeur and Chris Nicholson have been chosen to attend paramedic school. Since that time, Jacob Finnigan has also requested to attend paramedic school and Chief would like approval for Jacob to attend at the same time. Chief Benn feels that this is an excellent opportunity to acquire paramedics that want to live on the South Beach. There are immediate jobs secured for the first 2 candidates and possibly there could be a third position. Chief Benn stated he doesn't know if that is possible but there is always the chance. At best, Jacob could fill in shifts and still be an asset to the organization. Funding was questioned and Chief Benn answered that it will be funded through the "operational reserve fund". A motion was then made by Tom Bearden approving the expenditure of schooling for Jacob Finnigan. In addition, all three of the candidates will be paid while attending school as originally planned. This includes the benefit of medical insurance. Motion seconded by David McLellan. Motion carried.
- Monthly Call Volume: The monthly call volume was distributed to the board members for their review.
- 3. Water Tanks: The tanks have been purchased and we are waiting on a shipping date.
- 4. Commissioner Training-OPA and PRA: All commissioners have now attended the Public Records Act Training.
- 5. DNR Brush Truck Update: Chief Benn sated that fuel canisters have been ordered for the pump.
- 6. PIO/Public Educator Update: a. Job Fair: Well attended and received.
