CHIEF'S REPORT-BATTALION CHIEF DARIN VANDERVEUR:

BC VanderVeur stated that the Fire Academy program is ongoing. This will be the third class in a row with the largest number of attendees: 33. We have 6 attendees from South Beach.

Station 1 will host training for the Dolphin 1 on February 21st at 0900. All are invited to attend.

We will be decommissioning the line guns that we had. Hoquiam Fire Department has expressed interest in purchasing them from us.

On January 17, 2024, from 2:00-4:00 PM we will be hosting a Community Risk Reduction event. Chaired by our PIO Coleena Curry we will have demonstrations and participants from 038 and the Red Cross to name a few. This is the first open house that we have held at the training center.

We expect to have our new Scott Paks in service by February 1st. Calibration has been completed.

We have heard from GEO Techs and yes, we can build here. The next step will be to forward the recommendations to the architecture department.

CHIEF'S REPORT-BATTALION CHIEF DARYL BROWN:

BC Brown noted that he has been on shift for a month or so.

We are transitioning to ESO, our new data managements system.

CHIEF'S REPORT-FIRE CHIEF DENNIS BENN:

Action Items:

 Approve Bunker Gear purchase in the amount of \$26,424.16: Due to the wear and tear on our current bunker gear plus the addition of new employees, including part time, Chief Benn requested the board to approve \$26,424.16 for bunker gear. A motion was made by Tom Bearden to approve the purchase of \$26,424.16 from Sea Western-7 sets of gear. Motion seconded by Sam Schlegel. Motion carried. The quote had been distributed to the board members for their review.

- 2. Approve the upgrade and associated cost of the SCBA Air Cascade System at the Training Center: Chief Benn stated the need for the air cascade system to be upgraded. Distributed were two quotes for the board member's review. Quote 1 contained bottles and pipes in the amount of \$15,163.24 which includes lifetime certifications: received from Curtis. Quote 2 from Curtis in the amount of \$12,883.96 would require recertification. Discussion followed with Sam Schlegel making a motion to approve Quote 1 from Curtis in the amount of \$15,163.24. Motion seconded by Tom Bearden. Motion carried.
- 3.GEMT Audit: The GEMT (Ground Emergency Medical Transport) is ongoing.
- 4. Monthly Run Review: Chief Benn presented the monthly run review for the board.
- 5.Step 1-New Pay Grade: Distributed to the board was the new pay grade for 2024 due to the increase of minimum pay per hour.
- 6.Testing of EMT/Paramedic Student: BC VanderVeur was in charge of the testing process of 3 candidates for Paramedic Student. This was done in order to fill the vacant Paramedic position. The students who progress through the testing process will have a Chief's interview next week. We will be looking to place the applicant on shift, February 2nd. They will then attend Paramedic school in the fall of 2025. Chief Benn is currently working on a contract, clarifying expectations.

Board for Volunteer Firefighter meeting report: The Board for Volunteer Fire Fighter Fund meeting was held at 4:30 PM. No action taken.
